For the benefit of agriculture and to improve the quality of the aquifer, New Water will be supplied **free of charge**, up to a maximum of 2,500,000 litres per half-hectare.

Outstanding Debts

Application will not be accepted from a person who has outstanding debts older than six months on accounts held with ARMS Ltd or Water Services Corporation.

Responsibility of Applicant

The service in terms of this application shall be furnished in accordance to the pertinent legislation and without any prejudice to third party rights. The applicant is fully responsible for the accuracy and for the truthfulness of the information provided and any inaccuracy shall be dealt with in terms of the laws of Malta and shall result, amongst others, in the suspension of the supply, and /or in the institution of judicial proceedings. The access card is being issued in the applicant's name and cannot be transferred to third parties. The card remains property of WSC and if the applicant does not wish to continue using it, it must be returned. Any inappropriate use of the card will result in the suspension of service.

The Corporation will not accept responsibility for any interruptions of the New Water service.
